
Air Force Day- 8th October


World Standards Day-14th October

World Anaesthesia Day-16th October



International Day for Eradication of Poverty -17th October




Diwali -24th October


World Day for Audio-visual Heritage-27th October

- **4.** Jus scriptum Written law.
- **5. Modus operandi** Way of working. Or mode of operation.
- **6. Non Sequitur** A statement (such as a response) that does not follow logically from or is not clearly related to anything previously said.
- 7. Quantum meruit What one has earned. Or the amount he deserves.
- **8. Res Judicata Pro Veritate Accipitur** It means that a judicial decision must be accepted as correct.

- **1.** Sceptical Doubtful
- 2. Mesne middle, intervening or tame by nature
- **3. Erect** –rigidly upright or straight
- **4. Plagiarized** the act of appropriating the literary composition of another, or parts or passages of his writings, or the ideas or language of the same, and passing them off as the product of one's own mind.
- **5. Unfettered** not confined or restricted
- **6. Preclude** prevent from happening; make it impossible.
- 7. Ratio Legis according to the spirit of the law
