#### **LEGAL WORDS**:

- 1. Appeal: Asking a higher court to review the decision or sentence of a trial court because the lower court made an error.
- 2. Arbitration: Submitting a case or dispute to designated parties for a decision, instead of using a judge.
- 3. Bond Review: A hearing for a judge to decide if the defendant's bond amount needs to be changed.
- 4. Counter Claim: A claim by the defendant in a civil action that the defendant is entitled to damages or other relief from the plaintiff.
- 5. Disposition: The manner in which a case is settled or resolved.
- 6. Eviction: Legally forcing a tenant out of the rented property.
- 7. Foreclosure: A court order ending the legal ownership of property.
- 8. Hearsay: Testimony given by a witness who tells second or third-hand information.
- 9. Juvenile Probation: Placement of an adjudicated delinquent under the supervision of a juvenile probation officer.
- 10. Movant: The person who filed the motion, or request, to the court.

#### **LEGAL MAXIMS:**

- 1. A fortiori: From stronger
- 2. Volenti non fit injuria: No injury can be done to a willing person.
- 3. **Ex injuria jus non oritur:** Law (or right) does not arise from injustice.
- 4. Pacta sund servanda: Agreements must be followed.
- 5. **Corpus delicti:** Body of the crime.
- 6. **Actio personalis moritur cum persona**: Action dies with the person.
- 7. **Cessante ratione legis, cessat ipsa lex**: The cessation of the reason for the law, ceases the law itself.
- 8. Aequitas nunquam contravenit leges: Equity cannot contradict the law.
- 9. Actori incumbit onus probandi: Actor rests the burden of proof.
- 10. **Detur Digniori**: Let it be given to more worthy.
